An entry submitted and accepted constitutes a contract binding the Entrant to take part in the event either with the driver designated or with substitute drivers, unless prevented by force beyond his control. In submitting this entry the ABOVE SIGNED verifies he is acquainted with the rules of competition adopted by the Trinidad and Tobago Karting Association (TTKA) and the Supplementary Regulations for the Event and the racing kart being entered and described above complies with the said adopted TTKA Competition Rules and amendments there to. The ABOVE SIGNED grants permission for the series sponsor, events sponsors, events promoters and the TTKA to use his name, his photos and photos of his racing kart in advertising and promotional material, excluding product endorsements, issued in any connection with races and agrees to display the series emblem on the chest of the driver's uniform and the series decal on both sides of the racing kart while competing in such series race. All fees paid for entry to events are non-refundable.

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as including but not limited to the racing surface, pit areas, infield, shutdown area, and all walkways, concessions and other area appurtenant to any area when actively related to the event shall take place) or being permitted to complete on date, observe, work for, or for any purpose participate in anyway in the event. The ABOVE SIGNED for himself, his personal representatives, heirs and next of kin acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he enters and with which he becomes in contact with, and he does further warrant that his entry upon such restricted areas and his participation, if any, in the event constitutes as acknowledgement that he has inspected such restricted areas and that he finds and accepts the same as being safe and reasonably ruled for the purpose of his use and he further agrees and warrants that, at any time, he is in or about restricted areas and he feels anything to be unsafe he will immediately advise the officials of such and will leave the restricted areas.

The Abovesigned HEREBY RELEASES, WAIVERS, DISCHARGES AND COVENANTS NOT TO SUE Trinidad and Tobago Karting Association or any subdivision thereof, the promoter, participants racing association, track owner, officials, kart owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners, and lessees of premises used to conduct the event, and each of them, their officers and employees, all for the purposes hereon referred to as 'releases' from all liability to the Abovesigned, his personal representatives, assigns, heirs and next of kin for any and all loss or damage and claim or demands theorizer on account of injury to the person or resulting in death of the undersigned whether caused by the negligence of the releases or otherwise while the Abovesigned is in or upon the restricted area and/or competing, officiating in, observing, working for, or for any purpose participating in the event.

The Abovesigned HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, derange or cost they may incur due to the presence of the Abovesigned in or upon the restricted area or in anyway competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.

The Abovesigned HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

The Abovesigned HEREBY expressly acknowledges and agrees that activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. The Abovesigned HEREBY further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the country in which the events are conducted. ABOVE SIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement has been made.
